## Preface

Europe is witnessing a period of reconstruction and reorientation. Besides internal integration (keyword: currency union and the future political structure), the European Union is also preparing for imminent Eastern expansion. At the same time there are exciting processes of reorganisation under way in Eastern Europe. In part the transformation process has proceeded to such a degree that entry into the European Union is within reach. In other countries, however, the actual transformation process is still to the fore.

The situation in the newly created national states, as they are not in the process of reconstruction state structures, is totally different. Here a state administrative structure without constraints needs to be created out of the existing system.

These totally different but highly topical developments will be examined and discussed at the 3-day Conference on Integration and Transformation in Albania, Hungary, and Macedonia.

Apart from lectures by German participants, the agenda also features lectures by scientists from Albania, Macedonia, and Hungary.

The conference was supported through the "Stability Pact South Eastern Europe" under the auspices of the German Academic Exchange Programme (DAAD) and aimed to introduce qualified young scientists from Albania, Macedonia, and Hungary to an international and interdisciplinary research programme.

The conference was organized by the Research Project "Integration and Transformation in Europe (ITE)" at the Otto-Friedrich-Universität in Bamberg. ITE was founded by Bamberg University Professors in 1993 to coordinate research work in the field of integration and transformation in Europe.
