[INTRODUCTION]

he Council of the European Union is a key player in European decision-making and still one of the most puzzling institutions for EU research with regard to its inner workings. Over the last years, a number of pertinent quantitative and qualitative studies have addressed key questions, such as voting patterns and coalitions in different policy areas, socialization effects, the influence of external actors such as interest groups, informal negotiations, etc.

To improve research on the Council and gain better insight in the dynamics of decision-making processes, we wish to connect researchers of different theoretical and methodological backgrounds and encourage a debate about where research stands, what current methods can and cannot achieve and where we should head towards. With this workshop, we intend to provide an opportunity for young scholars to benefit from the advice of established researchers and discuss their research approaches. Indeed, research on European policy-making is a dynamic and evolving field and qualitative methods are being increasingly discussed as an alternative to study key EU institutions.

The workshop can thus help to share experiences of research done on and in the Council as well as establish links between all those dealing with this research area. The workshop will encourage interdisciplinary debates and provide opportunities to exchange on methods and findings of other disciplines.

Derek Beach is Associate Professor of Political Science at the University of Aarhus, Denmark, where he teaches international relations and methodology. He has been a visiting fellow at American University, Georgetown University, and Johns Hopkins School of Advanced International Studies.

He has authored numerous articles, chapters, and books on case study methods, international negotiations, and European integration, including a book that traces negotiation processes within the EU titled The Dynamics of European Integration (Palgrave MacMillan, 2005), and co-authored the book Process-tracing Methods: Foundations and Guidelines (Michigan, 2013). He serves as an Academic Co-convener of the ECPR methods schools.

Derek teaches qualitative case study methods at ECPR and IPSA summer and winter schools, and he holds numerous workshops and seminars on qualitative methods throughout the world.

Sandrino Smeets is historian, journalist and political scientist. He currently works as teacher and researcher in the fields of research methodology and political science. His primary research interest concerns power in (socio-political) interaction. In his PhD project he studied the negotiations in the EU Council of Ministers. The project focuses on Council negotiations with regard to the Western Balkans (2000-2010). This project was conducted in close cooperation with the Dutch Ministry of Foreign Affairs and the Permanent Representation of the Netherlands to the European Union in Brussels. He was a member of the Dutch delegation to the Council's Working Party on the Western Balkans (COWEB) and the Council's Working Party on Enlargement (COELA). In terms of current research, his interests pivot around negotiations in general and the intricacies of EU decision making in particular. Thereby focussing on the nitty-gritty behind closed doors part of the proceedings, rather than just the high level deal making.

From September 2012, he has been working as an Assistant Professor at the departments of Research Methodology and Political Science of the Radboud University Nijmegen, teaching a wide variety of course in the fields of (quantitative and qualitative) methodology and general political science. Next to this, he is a lecturer and simulation leader for Eurosoc, which develops and organizes EU simulations.

EUROPEAN UNIVERSITY VIADRINA



Raphael Bossong is a lecturer at the Europe University Viadrina and affiliated with the Institute for Peace Research and Security Policy, Hamburg. He is also a member of the Europe Viadrina B/Orders in Motion Centre, where he recently completed a project on EU border and internal security cooperation. He holds a BA in Social and Political Sciences from the University of Cambridge and a MA and PhD in International Relations from the London School of Economics.

His research focuses on European crisis management, transnational networks and the extension of risk or security governance across modern societies. Over the last years, he participated in several international research consortiums on these topics and contributed to leading academic journals. His recent publications include "European civil security governance" (2015, Palgrave, with H. Hegemann) and "Explaining EU Internal Security Cooperation" (2014, Routledge, with M. Rhinard).

Hans Nilsson

COUNCIL OF THE EUROPEAN UNION



Hans Nilsson holds a law degree (1979) from Uppsala University in Sweden. He has worked as a judge at the Court of Appeal in Jönköping, Sweden before entering private practice. In 1986 he joined the Legal Directorate of the Council of Europe in Strasbourg where he served the European Committee on Crime Problems and the European Committee on Legal Cooperation and its Sub Committees for 10 Years. He was a Secretary to Committees that drafted the 1990 Money Laundering Convention and two Conventions on corruption as well as Conventions on drugs trafficking and environment crime. In 1996 he was appointed as Head of the Division of Fundamental Rights and Criminal Justice at the Council of the European Union in Brussels. He was responsible for the implementation of the programme of measures on mutual recognition and all EU negotiations on legislative acts in the field of criminal law (and civil law from 1996 to 2004).

Since January 2015, he is responsible for all Procurement in the Council of the European Union and the European Council. In 2009, he joined the Swedish Permanent Representation as Minister and Head of the JHA Counsellors to head a team of Counsellors dealing with the Swedish Presidency until 31 December 2009 before returning to his Council post. He was also responsible at the Permanent Representation for the negotiations in Brussels for the Stockholm Programme on behalf of the Presidency and aspects of the implementation of the Lisbon Treaty. Mr Nilsson is a visiting Professor of the College of Europe since 1997, a member of the Advisory Board of the International Criminal Law Network and an author of more than 70 articles on International law, criminal law and EU law. He has been awarded the degree of Jur. Dr. honoris causa by the Uppsala University.

Christof Roos

VRIJE UNIVERSITEIT BRUSSELS



Before joining the Institute for European Studies at Vrije Universiteit Brussel, Christof Roos worked as research associate at University of Bremen (2007-2014). At Bremen International Graduate School for Social Sciences and the Collaborative Research Centre "Transformations of the State" he researched EU integration in Justice and Home Affairs. His focus is on EU immigration politics as well as single market issues such as freedom of movement, Schengen cooperation, and the common European asylum system.

As a member of the interdisciplinary research project "From Containers to Open States. Border Regime Change and the Mobility of Persons" he was co-author of the project monograph Liberal States and the Freedom of Movement. Selective Borders, Unequal Mobility. He studied political science at Free University Berlin (2000-2006) and at York University Toronto (2003-2004). Questions of inand exclusion and the right to membership and community are core to his studies. Outside of academia Christof Roos worked for the European Commission's DG Joint Research Centre in Ispra (Italy). There he contributed to a study on emigration from West African countries (2006-2007).

In 2013 and 2014 he consulted the European Affairs Department of the Senate Chancellery of the State of Berlin on the European strategy on Roma Inclusion as well as on the European Smart Cities and Communities Initiative.
