### **Short Outline**

The word *meta-analysis* literally means *analysis of analyses*. A meta-analysis is a quantitative literature review that combines the analyses of studies conducted on the same topic. Conducting a meta-analysis involves seven steps:

- (1) Formulating the problem
- (2) Searching the literature
- (3) Gathering information from studies
- (4) Evaluating the quality of studies
- (5) Analyzing and integrating the outcomes of studies
- (6) Interpreting the evidence
- (7) Presenting the results

Students enrolled in this class will receive hands on experience in conducting a meta-analysis on a topic of their choice. Please bring your laptop to class each day.
