Double degree program between the University of Economics, Prague (Finance and Accounting, MIFA) and the University of Bamberg (Master in Business Sciences and Master in Finance and Accounting).

## 1. General Information

Students of both institutions start in the winter semester at the home university and complete the first year of the program there. In the second year, students move to the host university and end the program with passing the state exam at the University of Economics Prague. In Bamberg, students of the University of Economics Prague can choose between the Master in Business Sciences and the Master in Finance and Accounting. The following tables give the overall structure of the double degree program.

## 2. Course of Studies for Students from the University of Economics, Prague

### 2.1 Study program and recognition tables for students who choose the Master of Business Sciences

#### 1<sup>st</sup> and 2<sup>nd</sup> semester at the University of Economics, Prague

Students complete the modules of the first year of the program Finance and Accounting in Prague, which are eligible for recognition in Bamberg. The details of the current program are given in the following table.

### 3<sup>rd</sup> and 4<sup>th</sup> Semester at the University of Bamberg

#### Program in Bamberg:

In Bamberg, students select the following modules in accordance with the current version of the studying regulations and examination rules (Studien- und Fachprüfungsordnung) of the Master of Business Sciences.



General Management:

In Bamberg, students have to complete **24 ECTS**. They can choose among the modules that are offered in the module group General Management.

Research:

In Bamberg, students have to complete **6 ECTS**. They can choose one module of the module group Research.

Thesis:

Students have to write a Master Thesis in Bamberg, which is worth **24 ECTS**. The Thesis must be completed following the rules of the University of Bamberg.

Languages:

In Bamberg, students have to complete **6 ECTS**. They can choose one module of the module group Foreign Business languages. Usually, Bamberg offers the following languages:

- Business English
- Business French
- Business Italian
- Business Spanish
- Business Russian

Students who got their university entrance qualification in a non-German-speaking country and who are not German native speakers can also select German language modules.

#### 3.1 Study program and recognition table for students in the Master of Business Sciences:

##### *1<sup>st</sup> and 2<sup>nd</sup> Semester at the University of Bamberg*

Students start in September in Bamberg and complete 60 ECTS of the Master in Business Administration following the module specifications in the accreditation tables in the general overview and following the rules of the respective module groups.

##### *3<sup>rd</sup> and 4<sup>th</sup> Semester at the University of Economics, Prague*

Students complete the modules of program Finance and Accounting in Prague, which are eligible for recognition in Bamberg. The details of the current program are given in the following table.
